CenterSquare was attracted to the Property due to its close proximity to major highways and population centers in a submarket with consistently low vacancy. The asset is in excellent condition and already meets the requirements demanded by today's discerning tenants. The joint venture executed a sale-leaseback with the seller at close of the transaction. CenterSquare intends to make targeted capital improvements including replacing HVAC units, upgrading ESFR sprinklers, and applying new energy efficient office finishes, all which contribute to the long-term sustainability of the property.

"3280 Corporate View is a prime example of the type of investment that we seek out for our value-added industrial portfolio given the property's functionality and high barrier-to-entry location," said Robert Wasenius, CenterSquare Vice President of Private Real Estate. "We are thrilled to be working with RPG, a repeat partner who brings deep knowledge and expertise in the market. We anticipate substantial interest from tenants given the limited availability of high quality, functional product in North San Diego."
